In view of the referred memo, you are requested to take the following action for implementation of App based survey in connection with Mission Antyodaya-Framework.

1. Complete the collection of information from village level before the special Gram Sabha meeting / General Body meeting and validate the same on the date of special Gram Sabha meeting / General Body meeting as per guidelines.
2. Gram Panchayat may be advised to form a team of two persons consisting of Executive Assistant or In-Charge of Executive Assistant and Gram Rojgar Sebak of the Gram Panchayat in a Gram Panchayat who will look after Mission Antyodaya Survey.
3. At block level, Block Development Officers are requested to entrust Block level Officer preferably Jt. Block Development Officer as Nodal Officer and Block Informatics Officer / Data Entry Operator for technical support in this regard.
4. At District level, the DP&RDO will act as Nodal Officer. The DIA, Purba Medinipur Zilla Parishad and three SSPs posted in the establishment of the DP&RDO will act as District Level Resource Person who would closely monitor the progress of the survey day to day.
